Mastering Class III Treatment with Damon System

Two tough class III cases, treated with Damon System, stable ever after



Moderate to severe class III cases, which are usually solved only with the surgical intervention, can be successfully treated with Damon system. Non-extraction approach is usually preferred, because the extraction procedure could aggravate the dished-in appearance which is prevalent in class III patients showing prognathic mandible and/or mid-face concavity. Also, the upper incisal display, which is already lacking because of the compensation, could be worsened with the conventional class III mechanics because the occlusal plane is more flattened. With the help of the sufficient orthopedic maxillary protraction and class III triangular shape elastics from the modified lip bumper, the patient showed the pleasing consonant smile after treatment by increasing the upper incisal display.

Even though it is rare, class III patient can be treated with extraction of premolars. Severe crowding, skeletal asymmetry and lower lip protrusion are the characteristics of 2nd case, in which extraction option is chosen. Lace-back ligation facilitates the decrowding procedure around the extraction space in the early stage of leveling. Using the sliding mechanics, not only the extraction space has closed efficiently but the arch form is preserved.
